**ARTICLE 1.500 CITY COUNCIL RULES OF PROCEDURE**

**Sec. 1.516 Addressing the Council**

Any person desiring to address the council by oral communication shall first secure the permission of the mayor; provided, however, that preference will be given to those persons who have notified the city secretary by noon of the meeting day of the council

meeting of their desire to speak in order that their names may be placed on the agenda, and they will be recognized by the mayor without further action.

Sec. 1.517 Addressing the Council After Motion Made

After a motion is made by the council, no person shall address the council without first securing the permission of the mayor to do so.

Sec. 1.518 Manner of Addressing the Council; Time Limit

- (a) Each person addressing the council shall step up to the microphone in front of the rail, shall give his name and address in audible tone of voice for the taped record and, unless further time is granted the council, shall limit his address to three minutes.
- (b) All remarks shall be addressed to the council as a body and not to any member thereof.

During the Town Hall Meeting presentations, the general public will be permitted to address questions to the presenters and comment on the subject matter of the presentations. You must be recognized by the presenter before being permitted to speak and must observe all city council rules of decorum.
