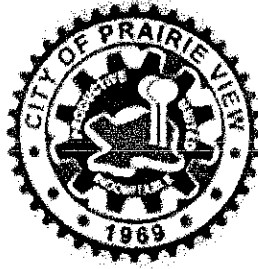

## 11. Mayor's Report

- First few months as Mayor, started cleaning up the city as promised by issuing over 100 Citations for Ordinance Violations; next step starting this month, assisting a Code Enforcement Officer to continue and keep properties maintained citywide.
- Economic Development Update on Projects in last 14 months:
  - \$1 million EDA Grant (approved) for water/sewer infrastructure along James Muse Parkway; (awaiting EDA in Austin, due by next week then RFP's can be submitted)
- \$350,000 Grant (approved) for improving old infrastructure in Alta Vista subdivision; approved by HUD, complete environmental next.
- SBEC project: New LED street lights around the city, several have been done, more to come; (Project with SBEC and Austin Energy Consortium, to replace ALL old street lights with New LED, pending)
- NEW Student Housing: (costing city money to have students living in other cities)
  - 1,400 new student housing project (Richards Road, land purchased)
  - 486 beds to start (Owens Road by new school, land purchased)
  - 40 beds (University Drive-land purchased)
  - 200 beds (Cochran Street-contract in place)
  - 40 Family Housing (Richards Road-land purchased)
  - \*Student Housing, 70% slated to be ready for 2018 fall semester
- Grocery Store (University Drive, land purchased, clearing and store planned)
- Jamaican/Caribbean Restaurant (University Drive-land purchased, Houston based)
- \$100,000 Smart City Grant, MOU with PVAMU Research Department (starting research soon, next step applying for \$1 million Smart City Grant, adding technology to PV)
