Under Texas Code of Criminal Procedure, Art. 45.0511 (Mandatory Dismissal through DSC or MOTC), you will not be able to take the driving safety course for case dismissal if:

- You have completed a driving safety course within the 12 months preceding the date of your citation
- You are the holder of a Commercial Driving License (CDL)
- You exceeded the posted speed limit by 25 mph or more
- You received a traffic violation in a construction zone with workers present

You must present your valid Texas driving license and current proof of financial responsibility, \$144.10 court costs/fees (in a regular zone) or \$169.10 court cost/feess (in a school zone).
